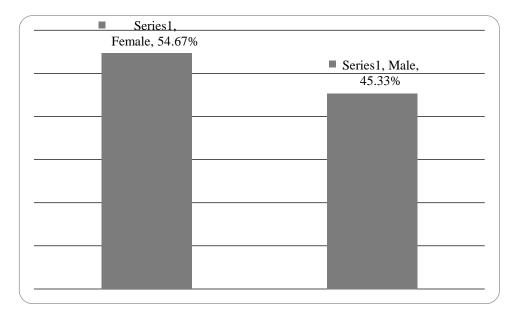


Figure 1: Distribution of Respondents by Gender

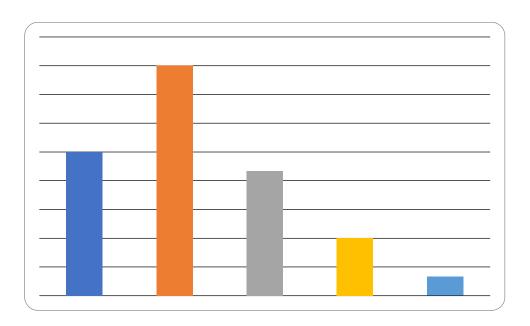


Figure 2: Distribution of Respondents by Age

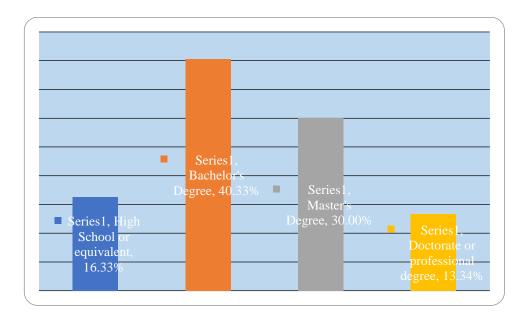
# Interpretation:

**Figure 3: Educational Level of Respondents** 

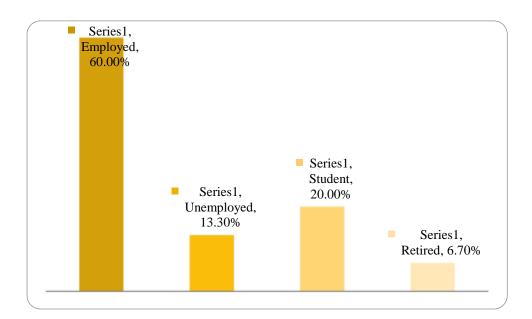
# Interpretation:

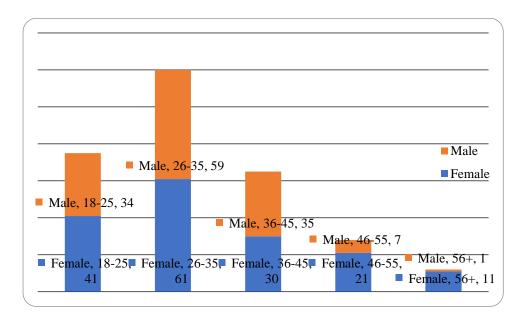


Figure 5: Cross-tabulation of Age and Gender

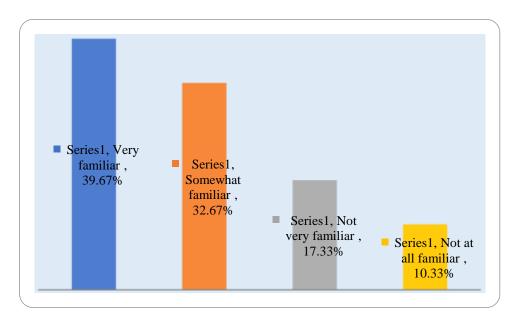


Figure 6: Familiarity with the Concept of Women Empowerment

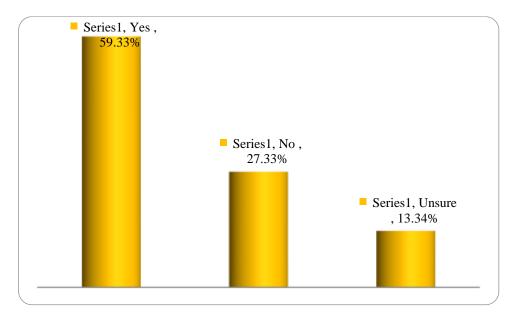


Figure 7: Belief in Equal Opportunities for Women in the Community

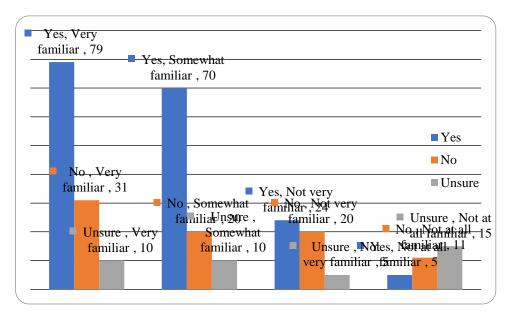


Figure 8: Cross-tabulation of Familiarity with Equal Opportunities Belief

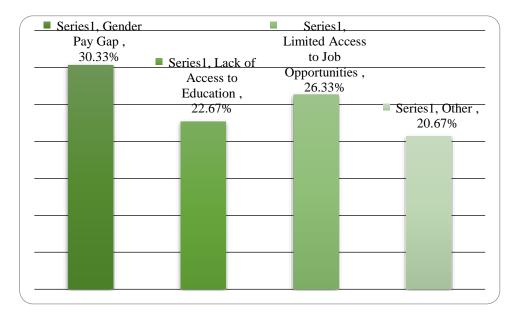


Figure 9: Most Significant Barrier to Women's Economic Empowerment

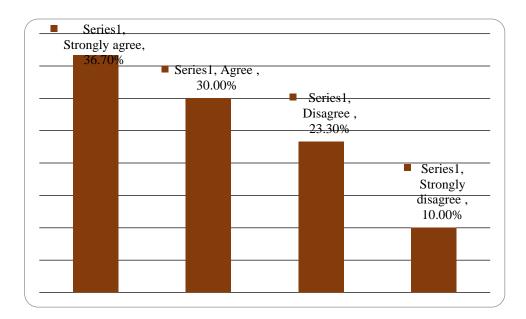


Figure 10: Affirmative Action Policies for Women in Leadership Roles

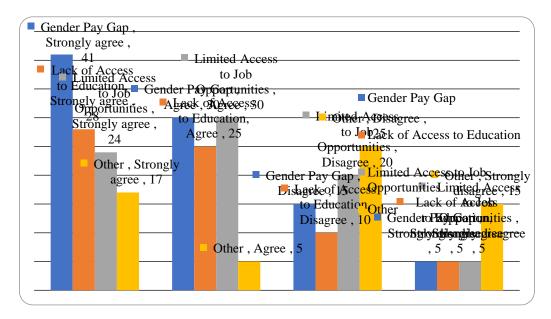


Figure 11: Cross-tabulation of Most Significant Barrier and Affirmative Action Support

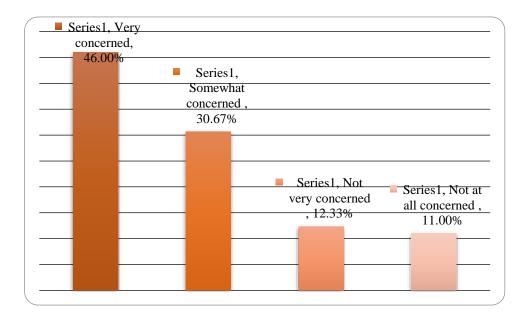


Figure 12: Concern About Gender-Based Violence in the Community

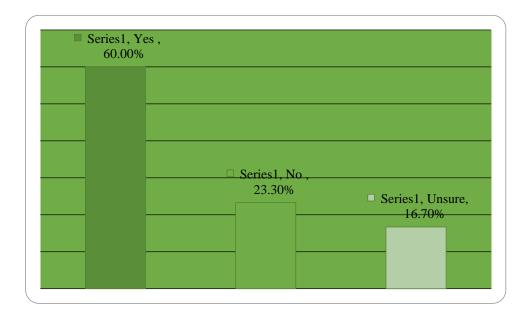


Figure 13: Perception of Media Reinforcing Gender Stereotypes

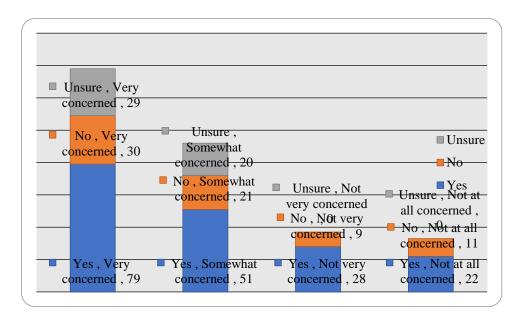


Figure 14: Cross-tabulation of Concern about Gender-Based Violence and Perception of Media

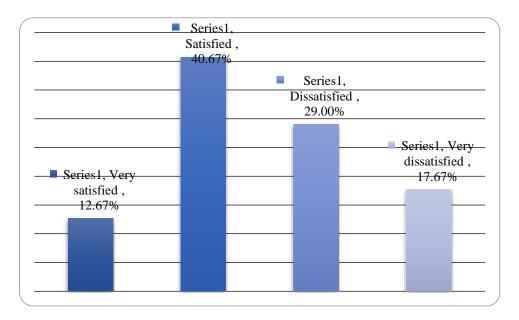


Figure 15: Satisfaction with Representation of Women in Political Leadership

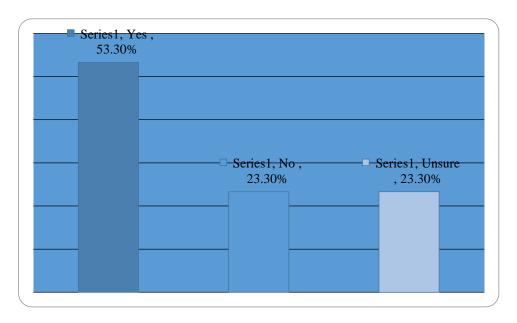


Figure 16: Perception of Effectiveness of Gender Quotas in Politics

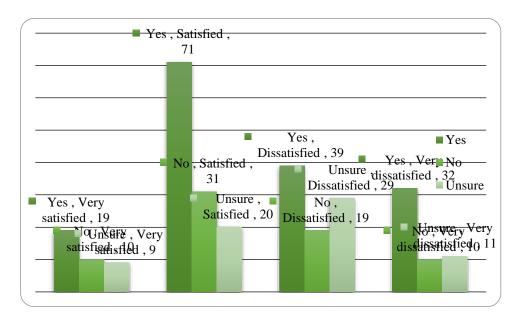


Figure 17: Cross-tabulation of Satisfaction and Perception of Gender Quotas

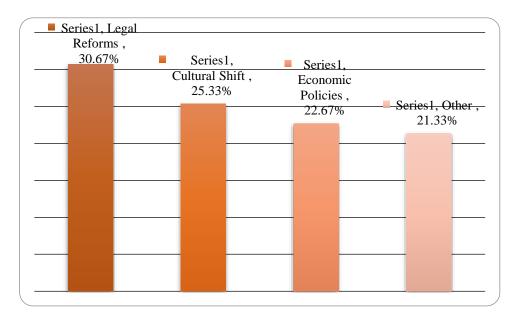


Figure 18: Crucial Factor for Achieving Women's Empowerment Globally

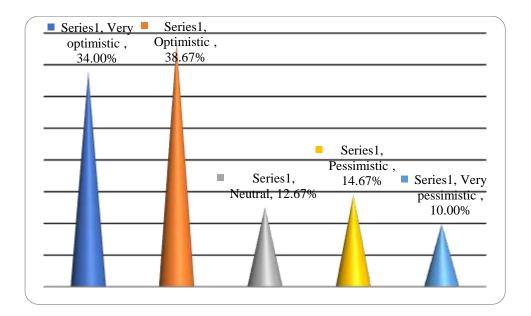


Figure 19: Optimism about the Future of Women's Empowerment

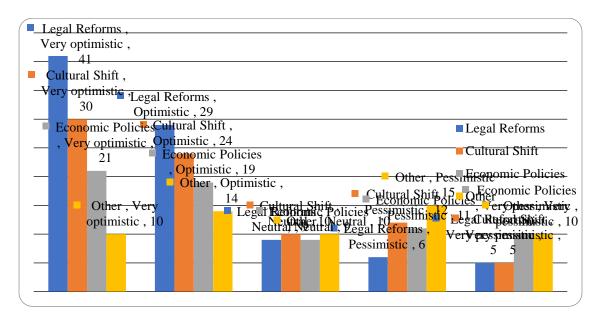


Figure 20: Cross-tabulation of Crucial Factor and Optimism
