Foreign Direct Investment (FDI) is widely acknowledged as a powerful tool to boost economic growth (EG), playing a crucial role in fostering accelerated development and promoting economic growth and diversification, particularly in developed countries like Saudi Arabia (SA). This paper delves into reviewing various research studies, offering a comprehensive exploration of Foreign Direct Investment (FDI) on a global scale. Consequently, it identifies the paramount challenges within host countries that significantly influence the inflow of FDI, along with key factors and challenges that practically impact FDI in the Saudi market. It investigates the economic dependence on politics, regulatory hurdles, social and cultural considerations, infrastructure, and the impact of Vision 2030, a transformative economic and social development plan. The challenges faced by the host country in attracting FDI include the need to strike a balance between attracting FDI and protecting national interests, ensuring compliance with local regulations and standards, managing the impact on the environment and natural resources, and addressing potential negative effects on local industries and employment. Policymakers, investors, and scholars need to work together to develop strategies and policies that mitigate these challenges and maximize the benefits of FDI for both the host country and the investor.

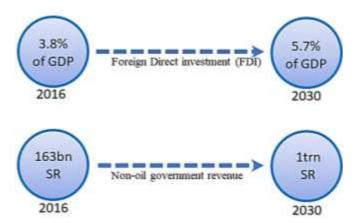


Figure 1: The primary goals of Vision 2030 A

This significance is particularly evident in developed countries like Saudi Arabia, where FDI fosters accelerated development and contributes to economic growth. This paper

conducts a thorough review, beginning with elucidating the meaning of FDI and exploring its various types. Furthermore, it provides an inclusive list of the advantages and disadvantages of FDI in host countries. The analysis extends to a global review of important factors influencing FDI inflows before narrowing its focus to the specific context of the Saudi market. However, as the global economy becomes increasingly interconnected, analyzing the key challenges influencing FDI in Saudi Arabia contributes to academic discourse and provides practical guidance for those involved in policy formulation and investment decision-making. Moreover, this paper aims to contribute to the ongoing dialogue surrounding FDI by shedding light on its intricate dynamics and offering actionable insights for stakeholders in the Saudi Arabian market. During the unveiling of the Saudi vision 2030 on April 25, 2016, His Royal Highness Crown Prince Mohammed bin Salman Bin Abdulaziz articulated two primary goals: firstly, to increase non-oil government revenue from SR163 billion to SR1 trillion, and secondly, to raise foreign direct investment from 3.8% to the international level of 5.7% of GDP [1] & [2]. These figures underscore Saudi Arabia's concerted efforts to diversify its revenue sources beyond oil-related income, demonstrating a strategic shift toward a more balanced and sustainable economic model. In the figure 1 demonstrates these goals.

2. Foreign Direct Investment (FDI)

This literature review has two main sections, i.e., FDI from a global perspective, key challenges influencing the Inflow of (FDI), and primary factors and challenges in the Saudi Market (SA). The primary objective is to furnish updated insights, focusing on research about Inward Foreign Direct Investment (FDI) more specifically. This refined approach aims to provide a holistic

understanding of recent developments, emerging trends, and noteworthy findings in the field, ensuring the currency and relevance of our literature exploration.

2.1. Foreign Direct Investment (FDI) from a Global Perspective Foreign direct investment (FDI) is a pivotal force driving economic growth globally, fostering job creation, and facilitating the exchange of technology and knowledge across nations. It is considered a key driver of globalization and international trade. Governments worldwide often employ incentives and policies to attract FDI, recognizing its potential to bring capital, expertise, and access to new markets [3], [4] & [5].

Hussain & Hague also describe Foreign Direct Investment (FDI) as representing investments made by companies or individuals from one country into another to establish business operations or acquire assets. In terms of types, Foreign Direct Investment (FDI) exists in two primary forms: Inward FDI, which entails the investment of foreign capital in a host country, and outward FDI, which refers to investments made by the host country in foreign markets. Inward FDI involves the transfer of tangible or intangible assets, making a more significant contribution to the host country's economy.

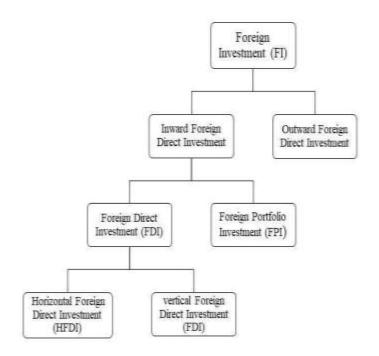


Figure 2 Breakdown of Foreign Direct Investment (FDI) [ibid].

In addition, it encompasses Foreign Portfolio Investment (FPI), which typically focuses on capital gains [6]. The difference between the amount of investment flowing into and out of a country is called the Net Flow of Foreign Direct Investment. Establishing new facilities and subsidiaries in the host country, known as greenfield FDI, brings substantial benefits, fostering capacity development and contributing directly to economic growth [7]. In theory, there are two existing FDI categories, i.e., Horizontal and Vertical types. Horizontal FDI involves companies investing in the same industry abroad as they operate domestically, replicating existing operations. In contrast, Vertical FDI occurs when companies strategically distribute production processes across different countries, optimizing cost-effective resources at each production stage [8] & [9]. Based on previous studies, figure 2 illustrates a breakdown of Foreign Direct Investment (FDI).

As the relationship between foreign direct investment (FDI) and economic growth unfolds, it becomes evident that contrasting viewpoints emerge from extensive research. While some studies suggest a positive correlation between FDI and economic growth, others highlight the potential adverse effects in certain countries [3], [4], & [5]. [10] outline benefits for investors, including global expansion and cost minimization. Simultaneously, advantages for host countries involve attracting FDI, fostering economic growth, integrating technology, and promoting innovative ideas. However, potential drawbacks include the creation of dependency and prioritization of profit over host state development [11] & [12].

Table 1 below summarizes the pros and cons of key challenges affecting Foreign Direct Investment (FDI) [10] & [13].

The study conducted by [14] sheds light on the challenges influencing Foreign Direct Investment (FDI) dynamics in Saudi Arabia. Key elements include substantial oil revenues and government involvement in crucial industries. Despite initial challenges with negative FDI inflows until 2004, strategic policies, such as joining the World Trade Organization (WTO), led to a significant increase in FDI since 2005, even amid the global financial crisis. Furthermore, the unveiling of Saudi Arabia's Vision 2030 in 2016, articulated by Crown Prince Mohammed bin Salman Bin Abdulaziz, set ambitious goals to raise FDI from 3.8% to 5.7% of gross domestic product (GDP) to reach international standards. Based on the (General Authority for Statistics, 2016). It defines

GDP as "the sum of values added by the domestic producers to the product price, plus customs tariffs". Alternatively, it is the sum of all outputs, less the sum of intermediate consumption plus the indirect taxes on products (taxes, subsidies, etc) not included in the output's values". Also, in the 2014 World Investment Report by the United Nations Conference on Trade and Development (UNCTAD), Saudi Arabia ranked third in terms of the highest number of Foreign Direct Investments (FDI) in Western Asia [15].

Despite lagging in moving forward to attract foreign investments to the Saudi market [16], returns have recorded promising numbers in recent years; the latest data from the General Authority for Statistics in 2023 highlights FDI Inflows of approximately 17 billion SAR and Outflows of around 5 billion SAR during Q3 2023, resulting in a net FDI flow of 11 billion towards 'sustainable FDI.' The data report highlights prioritizing the following criteria, i.e., low carbon footprint, strict adherence to human rights, maintaining workplace safety, preventing discrimination, and upholding transparency standards. The increasing recognition of the importance of environmental, social, and governance factors in investment decision-making drives the strategic shift towards ESG investing. ESG investing considers companies' sustainability and ethical practices, aiming to generate long-term value while considering the impact on the environment, society, and corporate governance. This shift aligns with broader goals related to sustainable development and responsible investment practices, as emphasized by the Columbia Center on Sustainable Investment

2.2. The Key Factors and Challenges Influencing the Inflow of Foreign Direct Investment (FDI) Globally and in Saudi Arabia In the contemporary global landscape, foreign direct investment (FDI) faces diverse challenges. For developing or underdeveloped nations, FDI is a crucial driver of economic growth, often deemed the most viable option. Consequently, these countries consistently endeavor to attract investors, with certain influential factors playing a key role in enticing them [10].

[17] study sheds light on Southeast Asian countries, revealing that trade liberalization and the quality of human resources consistently exhibit positive impacts on attracting FDI. However,

factors such as the urbanization rate, population size, and tourism numbers do not significantly affect FDI in the region. [18] conducted a comprehensive analysis of FDI inflows, considering characteristics like economic growth rate, government policy, labor markets, inflation, trade openness, foreign reserves, and natural resource availability. [19] emphasized market size as a critical factor in foreign investors' evaluations, using an empirical model to assess economic variables impacting the host country. Additionally, foreign investment was highlighted as adding substantial value to an economy by increasing the availability of local capital [20].

In Iraq, [21] emphasized the strategic importance of understanding the relationship between the investment environment and FDI, pointing out the crucial roles of gross domestic product (GDP) growth rate and inflation rates. However, the model did not incorporate random factors impacting investment attraction, including political and security factors deterring foreign investment. Shifting to Africa [22], identified infrastructure gaps, low domestic savings, and price inflation as mitigating factors hindering FDI between 1970 and 2021. [23] promotes inflation targeting as a strategy to attain FDI-attractive factors, including good governance and macroeconomic stability. Analysis indicates that countries adopting inflation targeting saw a 3-percentage-point increase in FDI compared to those not implementing this approach. In context of the Saudi Arabia market, Historically, Foreign Direct Investment (FDI) has played a pivotal role in the Kingdom of Saudi Arabia (KSA), particularly in supporting oil exploration, refining, and the establishment of major conglomerates like ARAMCO and Saudi Arabian Basic Industries Company (SABIC). Beyond the oil sector, FDI has contributed significantly to infrastructure and the banking industry [17]. To attract more foreign investors, the Saudi Arabian government adjusted FDI rules and regulations in 2000, involving a comprehensive revision of corporate laws and trade-related regulations [24]. The current investment environment in Saudi Arabia is defined by key factors that attract foreign investment. These include the announcement of Saudi Vision 2030, the strategic location of Saudi Arabia, real estate opportunities, and a leading financial sector [25]. Figure 3 illustrates the three fundamental pillars identified by the Saudi government to guide its strategic direction. The first pillar centers around the aspiration for a dynamic society rooted in fulfilled lives and strong foundations.

The second pillar emphasizes the establishment of a robust economy offering promising prospects, long-term investments, a business-friendly environment, and the utilization of its strategic position. The final pillar aims to establish an ambitious nation characterized by effective governance and responsible enablement [1].

The three pillars comprised six overarching level 1 objectives, cascading into twenty-seven branch objectives at level 2, and eventually spreading to ninety-six strategic objectives at level 3. According to the Vision2030 [Ibid], this vision was systematically cascaded into strategic objectives to facilitate effective implementation through Vision Realization programs. As outlined on the Vision2030 website, eleven Vision Realization programs are strategically leading and overseeing the implementation of initiatives executed by public sector organizations, all directed toward the achievement of the goals set forth in Vision 2030.

Engineer Khaled bin Abdulaziz Al Falih, 2023, the Minister of Investment, announced a new methodology for enhancing data quality and transparency in the Kingdom to empower investors and decision-makers. This initiative aligns with broader goals such as the National Investment Strategy, special economic zone development, global supply chain initiatives, and mega-project launches. The commitment to data enhancement supports the Kingdom's objectives and strengthens its global investment position. Various strategies can encourage foreign companies to enter the Saudi Arabian market. Incentives and benefits, such as tax incentives, access to government contracts, and simplified visa processes, can attract foreign companies. Establishing special economic zones with relaxed regulations and attractive investment opportunities is another effective strategy [26].

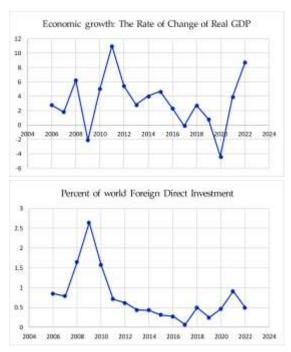


Figure 4 Economic Growth [27]

Figure 4 provides a visual representation of Saudi Arabia's economic growth rates spanning from 2006 to 2022. Noteworthy is the noticeable impact of governmental policies and regulatory reforms, particularly post-2016, aligning with the inception of the Saudi Vision 2030 initiative. This period witnessed a significant increase in economic growth rates, rising from around 2% in 2016 to nearly 9% by 2022. Such a substantial increase underscores the tangible benefits derived from the strategic initiatives outlined in the Vision 2030 agenda. Furthermore, figure 5 depicts the percentage of world Foreign Direct Investment (FDI) in Saudi Arabia relative to GDP from 2006 to 2022. A discernible upward trend is evident, indicating the increasing attractiveness of the Saudi market to foreign investors. This trajectory underscores the growing appeal of Saudi Arabia as an investment destination [27].

Promoting Saudi Arabia as a strategic hub for regional and international business and providing support for foreign companies to navigate the local business environment, including assistance with licensing and regulatory compliance, are additional measures. Fostering partnerships and collaborations between

foreign and local companies facilitate knowledge transfer, technology exchange, and market entry for foreign companies [28] & [29]. In a different context, [25] indicated that GDP growth rate, domestic investments, and natural gas reserves played pivotal roles.

3. 3. Research Findings

Previous studies acknowledged the importance of diversifying economic incomes; there is a crucial need to investigate the implementation of these strategies and their tangible outcomes in achieving the targeted FDI objectives. Table 2 outlines the pivotal factors influencing the positive or negative aspects of attracting foreign direct investment in the Saudi market, providing a comprehensive overview of the key determinants discussed in the literature review.

The research in the Foreign Direct Investment (FDI) field in Saudi Arabia has predominantly centered on examining strategies designed to attract investors. However, a notable research gap emerges after a comprehensive literature review. Specifically, there is a dearth of assessments regarding the strategies employed to enhance FDI in Saudi Arabia and their direct and indirect impacts within the economic goals outlined in the Vision 2030 initiative. This research aimed to address the gap by exploring the challenges and opportunities associated with FDI in Saudi Arabia, considering the socio-economic environment and ongoing reforms outlined in Vision 2030.

4. Conclusion and Recommendation

4.1. Conclusion

This paper has studied the significance of Foreign Direct Investment (FDI) for economic growth, particularly in the context of Saudi Arabia's Vision 2030 goals. The investigation explored the various advantages and disadvantages associated with FDI, along with the key factors influencing its inflow. The unique situation of

Saudi Arabia was highlighted, including its historical reliance on oil revenue and the government's recent efforts to attract foreign investment through strategic reforms. A critical research gap was identified: a lack of evaluation regarding the effectiveness of implemented FDI attraction strategies and their alignment with Vision 2030's economic goals. The study proposes a comprehensive framework for evaluating the effectiveness of FDI attraction strategies in Saudi Arabia. The framework consists of four key components: policy and regulation, infrastructure, business environment, and human capital. Each component was further divided into sub-components, allowing for a detailed assessment of specific indicators. The study also recommended utilizing a combination of qualitative and quantitative methods, such as expert surveys, case studies, and statistical analysis, to measure the impact of FDI attraction strategies on Saudi Arabia's economic growth.

4.2. Recommendations:

Based on the gap that was found and the literature evaluation, this study makes the following recommendations:

- Evaluate the Effectiveness of FDI Attraction Strategies:
 Conduct a comprehensive assessment of the various strategies implemented by Saudi Arabia to attract FDI. This evaluation should analyze the effectiveness of these strategies in achieving the specific FDI targets outlined in Vision 2030. These recommendations aim to enhance Saudi Arabia's FDI attraction strategies, align them with Vision 2030 goals, and maximize the benefits of foreign investment for the country's economy.
- Align Strategies with Vision 2030 Goals: Analyze the alignment between FDI attraction strategies and Vision 2030's economic objectives. This includes ensuring that targeted sectors for FDI, such as renewable energy and technology, receive adequate support and incentives.
- Assess Indirect Impacts: Explore the indirect impacts of FDI on Saudi Arabia's economy beyond simply increasing FDI inflows. This could involve investigating factors like job creation, knowledge transfer, and technological advancements.
- Promote Transparency and Data Quality: The Saudi government's recent focus on improving data quality and

- transparency regarding FDI statistics is commendable. This initiative should be further strengthened to empower investors and attract foreign capital.
- Develop a Skilled Workforce: Saudi Arabia should fund education and training initiatives to give its workforce the know-how that foreign investors want to take advantage of FDI prospects.
